**APPROVAL – REZONING – 1226 MCDEVITT ROAD – BEAUTY SHOP**

**FROM RU-1 TO C-1**

**CASE#04-05-0015**

Public Hearing was held by the Planning Commission on May 13, 2004 on the request of Gary R. Weinhardt of 4263 Kibby Road, Jackson, Michigan, to rezone property located at 1226 East McDevitt from Urban Residential (RU-1) to Local Commercial (C-1) to allow a beauty shop to operate at the facility previously occupied by the Community Temple Association. The Planning Commission unanimously recommended to the Township Board approval of the rezoning request for property located at 1226 East McDevitt from Urban Residential (RU-1) to Local Commercial (C-1) to allow the operation of a beauty shop.

Public Hearing was held by the Planning Commission on May 13, 2004 on the request of Norfolk Development of 6360 Jackson Road, Suite F, Ann Arbor, Michigan, to rezone approximately 180 acres on property located north of the 4000 block of McCain Road and west of the M-60 by-pass, owned by Summit Tree Farm LTD of 420 Ingham Street, Jackson, Michigan, from Agricultural (AG-1) and Light Industrial (I-1) to Planned Residential (PR-1) to allow the building of Site Condominiums, both attached and detached, as well as rental units. The Planning Commission unanimously recommended to the Township Board approval of the rezoning request from Agricultural (AG-1) and Light Industrial (I-1) to Planned Residential (PR-1) to allow for the development of a Site Condominium Development.

Motion by Heins, supported by Hoyt and on roll call vote unanimously carried to approve the rezoning request for approximately 180 acres located north of the 4000 block of McCain Road and west of the M-60 by-pass from Agricultural (AG-1) and Light Industrial (I-1) to Planned Residential (PR-1) to allow for the development of a Site Condominium Development.
