APPLICANT SIGNATURE

Section 23a of the State Construction Code Act of 1972, 1972 PA 230, MCL 125.1523 A, prohibits a person from conspiring to circumvent the licensing requirements of this State relating to persons who are to perform work on a residential building or a residential structure. Plumbing work shall not be started until the Permit is issued. Work shall not be concealed until it has been inspected. **TO SCHEDULE AN INSPECTION, PLEASE CALL 517-788-4113.**

Permit is valid as long as the work is in progress and inspections are conducted. A permit will expire when work is not started within six (6) months, or when inspections are not called for and completed within six (6) months of the previous inspection. An expired permit cannot be refunded or reinstated.
