**APPROVAL – INDUSTRIAL FACILITIES EXEMPTION CERTIFICATE**  
**WORTHINGTON SPECIALTY PROCESSING**

Public Hearing was held on the Industrial Facilities Exemption request from Worthington Specialty Processing. Worthington Special Processing was represented by John Cassucio, plant engineer. The legislative bodies which levy ad valorem property taxes within the Township were notified of the public

hearing. No one appeared in opposition. The request was for an exemption of \$403,056 for investment of machinery and equipment for ten (10) years. The Assessing Department recommended the application be granted for eight (8) years.
