# APPROVAL – CONDITIONAL USE AND SITE PLAN – 2121 FERGUSON ROAD VERIZON CELL TOWER – SUMMIT TOWNSHIP, OWNER BEN VARNEY, PYRAMID NETWORK SERVICES CASE#15-05-0007

Public Hearing was held at the request of Ben Varney of Pyramid Network Services, representing NEW PAR of 4700 Hunt Street, Cass City, Michigan 48726. NEW PAR is a Delaware partnership doing business as Verizon Wireless and is requesting a Conditional Use Permit to construct a one hundred fifty (150) foot monopole cell tower to be used for wireless communication. Installation will be along the south side of Ferguson Road and west of South Jackson Road. Additional height of a lightening rod still brings the tower to less than two hundred (200) feet, therefore, the tower will not require lighting. A prefab ten (10) by eleven (11) State of Michigan approved equipment shelter will be installed at the base of the tower as well as a 1000 gallon propane tank and generator. The entire area will be fenced. The monopole cell tower will replace the existing tower and the antennas from the fire station tower will be installed on the new tower. The Planning Commission recommends to the Township Board of Trustees approval of the Conditional Use Permit and Site Plan at 2121 Ferguson Road for a cell tower one hundred fifty (150) feet in height contingent upon compliance with the requirements of the Jackson Department of Transportation, Jackson County Drain Commissioner, Jackson County Airport, Summit Township Fire Department and the Lease Agreement between Summit Township and Verizon.

Motion by Trudell, supported by Way, and on roll call vote unanimously carried to approve Conditional Use Permit and Site Plan at 2121 Ferguson Road for a cell tower one hundred fifty (150) feet in height contingent upon compliance with the requirements of the Jackson Department of Transportation, Jackson County Drain Commissioner, Jackson County Airport, Summit Township Fire Department and the Lease Agreement between Summit Township and Verizon.
