Rick Wilson, Appointed by the Board of Trustees, is the Superintendent of Recreation for the City of Jackson. His expertise is in recreation for adults and kids.

James Dunn, Planning Commission Liaison, has no recreation background. He would like to see this committee focus on trails.

Natalie Stopyak, background is in Recreation Administration and Environmental Activities. She designed a City Park for Kalamazoo and currently provides remediation management and environmental due diligence for property acquisition and sales.

The committee agreed that their future efforts would focus on the constructing and maintaining of non-motorized trails.

J. Dunn would like to start by prioritizing things, and finding a direction for the committee.

J. Worden, went over the term limits for each committee member: Kurt Rudolph 2007; Natalie Stopyak 2006; James Dunn and Rick Wilson were appointed by the Summit Township Board of Trustees.

K. Rudolph asked if anyone knew of a student in the Vandercook Lake area that would be interested in joining this committee. Kurt is interested in promoting walking among students.

R. Wilson stated he knew the principal at Vandercook Lake and he would contact him for a student suggestion.
